WELCOME TO THE 2024 FAMILY BUDGET SURVEY

This survey is conducted among retired European Union staff, staff on invalidity, widows/widowers and orphans receiving a pension from a European Institution. Thank you in advance for your participation.

Introduction

Harmonised surveys are conducted by Eurostat (the Statistical Office of the European Union) in collaboration with other partner international organisations such as the ISRP (International Service for Remunerations and Pensions of the Coordinated Organisations), the EPO (European Patent Office) and Eurocontrol (European Organisation for the Safety of Air Navigation). The purpose is to collect specific information on spending in order to **estimate an average expenditure pattern** for retired international staff and their families in each Member State.

The resulting pattern is an essential element in the calculation of post adjustments, purchasing power parities (PPP) and the correction coefficients (CC) applicable to the pensions of European Union officials as well as the retired staff of other international organisations.

The results of this survey will have an impact in the calculation of pensions, and therefore you have a direct interest in completing the survey. Only you possess the necessary information to evaluate your household expenditure, which is the object of the survey.

Please note that the aim of the survey is not to know how much money you spend, but what you spend it on. This means that the pattern of your expenditure will allow us to give adequate importance to different items in a basket of goods and services at the time of calculating the PPP.

INDIVIDUAL DATA PROTECTION:

In conducting this survey, we observe the rules and conditions on the protection of natural persons with regard to the processing of personal data, including the Regulation (EU) 2018/1725.

Your participation in the survey is voluntary. Some questions are mandatory, others are optional. The information you provide will remain **completely anonymous**. Its origin cannot be traced, since there is no name or identifying number on the questionnaire. The submitted questionnaires will not be communicated to the administration of your Organisation: the data will be processed by a limited number of statistical experts in Eurostat. If you have any questions about this, please refer to the **FBS data protection register entry** and the **FBS privacy statement**.

The information provided will be combined with that of other persons in order to calculate the average consumption structure of international retired officials in your place of residence. Therefore, in order to obtain statistically viable results, a maximal number of replies is vital to ensure a balanced, representative profile of the population. For example, one goal will be to avoid a situation with replies only from male /female, old/young, single/married, with/without children, low/high income, previously temporary/permanent officials, just arrived/long established, single/multiple nationality, expatriate/indigenous, city centre/rural, etc.

Before you begin to fill in the questionnaire, please read the detailed instructions carefully at the start of each section as well as the Important General Guidelines right below.

Important General Guidelines

Before starting to fill in the questionnaire, it may be helpful to compile information about your consumption during the reference period (e.g. contract agreements, subscription renewals, invoices, supermarket till receipts, credit card records, bank statements, insurance records, health claims and reimbursements, education declarations and allowances, tax returns.

Please take the necessary time to complete all sections of the questionnaire. **Remember that an incomplete questionnaire is not likely to be usable, and your efforts will be wasted.** If you forget to record the purchase of a bus ticket or a newspaper, this will have little impact on the overall quality of the results; however, your best estimate for an expense is better than leaving a blank.

If you cannot find an expense item in one of the boxes provided, please consult the detailed list of expenditures at the end of the survey which indicates where certain items are classified, and use the **section 5 “OTHER EXPENSES”** to specify as much as possible the nature and the amount of your expenditure.

You can **save the partially completed questionnaire** at any time and recover it later for completion.

Please note that all expenditure you report in the survey must be in the currency of your country of residence. For ‘Purchases OUTSIDE the country of residence’, please specify country or countries and convert all expenses into the same currency of your country of residence.

The expenses you should record are those **for the entire household**, and not those only paid by you.

Record any gifts in the corresponding expenditure area relating to the gift. For example, the purchase of a gift of jewellery under “jewellery” in question 66. A gift of a toy under “toy” in question 52.

Section 1: Personal information

Specific Guidelines

The basic information provided in this section is essential to validate the survey results and to aggregate them to the total population of international retired officials in your place of residence.

The first question identifies your **main place of residence** (country and city).

The next question identifies your age, which is a standard variable in such surveys, providing important context to help understand your spending pattern.

Then we ask about the number of persons belonging to your household, either living at the same address or elsewhere. This is also a standard variable providing important context to help understand your spending.

Then we ask some questions about your household income, which is another standard variable providing important context.

Finally, we ask about your former employer, which is also an important analytical variable.

Section 2: Dwelling expenditure (incl. rent/mortgage)

Specific Guidelines

Part (a) of this section (**Main dwelling information**) : This information relates solely to your main dwelling in your country of residence.

If you have other dwellings than your main residence (e.g. an apartment elsewhere in the same country or a house in another country), you will be able to fill in expenditures related to that dwelling in **parts (b) and (c)**.

As the accommodation cost is a very important element in the calculation of correction coefficients, it is essential that all related questions are answered and that the total area of living space is filled in accurately. If you are a **tenant**, please record your current monthly rent, excluding charges for utilities and other services such as common lighting, elevator, etc. Service and utility charges are then to be shown in the table after the declaration of rent (Dwelling related regular bills).

Exclude any payments for garages, unless this is an integral part of your rent.

If you are the **owner** of your accommodation and if you bought it on a mortgage or any other loan, please state your current monthly loan payment (capital plus interest), but excluding any life insurance.

The table after the declaration of rent (**Dwelling-related regular bills**) concerns your main expenditures such as water, electricity, telephone, etc.

The cost of hybrid packages (internet, telephone, etc) should be declared with landline/mobile phone bills. NB. The purchase of telephone equipment should be declared elsewhere (Q40).

Section 3: Household expenses

Specific Guidelines

The main purpose of the survey is to estimate the average expenditure pattern of households. Each question allows you to include your purchases either over an average month, or in the last year.

The consumption pattern will be calculated on the basis of annual expenditure. Therefore, if you enter a monthly amount, the questionnaire will automatically calculate your expenses over the 12 month period on this basis.

The first columns relate to "Purchases INSIDE the country of residence" (main dwelling and secondary dwelling in same country, if applicable).

Please only enter a figure in one of the columns (i.e. average month or last 12 months).

Any household expenditure in another country should be recorded under "Purchases OUTSIDE the country of residence". In this case, please indicate the country or countries, and the total annual amount of these expenses converted to the currency of your country of residence, when applicable.

If there is no expenditure for a given item, please enter '0'.

Purchases via Internet: All purchases made via Internet are considered as expenses made in your country of residence, provided that the purchased goods are delivered to your country of residence.

If you cannot find an expenditure item in one of the boxes provided, you can search the detailed list of expenditures, or record this in section 5 "Other expenses".

Specific Guidelines - food, beverages and tobacco

For questions 10 and 11 (Food and non-alcoholic beverage), you are asked to record, for a typical 1 month period (including weekends), your own expenditure as well as the expenditure of other members of your household on food and food-related items and non-alcoholic beverages. Questions 12 and 13 then ask about alcoholic beverages and tobacco products. Questions 14 and 15 relate to food consumption away from home in restaurants and canteens.

It is not necessary for you to break down food expenditure into sub-categories (e.g. bread, meat, fish, dairy, fruit, vegetables).

NB. Food for pets should be recorded separately (Q54).

Question 14 "Restaurants, cafes, bars, take-away" refers to purchases of food, beverages, ice creams, etc. in any of these places, or when delivered to your home/office.


